As lawful consideration for these services and/or related support activities with and/or through Donavon Photography, Inc., its assigns or affiliates, to participate in said related photographic and/or related support activities and the use of their facilities and equipment, I hereby agree that I, my heirs, distributees, guardians, legal representatives and assigns will not make a claim against, sue, attach the property of or prosecute Donavon Photography, Inc. and/or any of its assigns or affiliated organizations for injury or damage resulting through either negligence or for any other reason; howsoever caused, by any employee, agent, affiliate photographer, nonaffiliate photographer, contractor, subcontractor, vendor, client or potential client of Donavon Photography, Inc., its assigns or affiliates as a result of my participation in all modeling-related activities, including (but not limited to) injury or damages resulting from equipment and/or electrical failure or malfunction; acts of nature; model tardiness; model no-shows; model personality-related problems; late or cancelled bookings; scheduling problems; lodging and travel-related problems; illness or accidents; unintentional omission or incorrect crediting of copyright acknowledgment; payment delinquency; film processing and development problems; lost, stolen or damaged film, negatives or prints; and use of unauthorized or dangerous shooting locations.

In addition, I hereby release and discharge Donavon Photography, Inc., its assigns or affiliated organizations from all actions, claims, or demands that I, my heirs, distributees, guardians, legal representatives or assigns now have or may hereafter have for injury or damage resulting from my participation in any modeling activities associated with Donavon Photography, Inc., including (but not limited to) injury or damages resulting from equipment and/or electrical failure or malfunction; acts of nature; model tardiness; model no-shows; model personality-related problems; late or cancelled bookings; scheduling problems; lodging and travel-related problems; illness or accidents; unintentional omission or incorrect crediting of copyright acknowledgment; payment delinquency; film processing and development problems; lost, stolen or damaged film, negatives or prints; and use of unauthorized or dangerous shooting locations.
